Dear parents and carers,

From Monday 25 February to Wednesday 27 February the Year 5/6 students will be going on a camp to Borambola, near Wagga Wagga.

The cost of the camp is **\$320** per student. This includes transport to and from the camp, as well as meals, accommodation and all activities. **Payment for the camp is due by Tuesday 11 December 2018.** **The school will incur significant penalties by the provider if any changes are made to our numbers, therefore students will not be able to attend camp if full payment is not made by this date.** Camps provide a great opportunity for students to develop teamwork, social skills and independence and all students are strongly encouraged to attend.

Please contact the Front Office if you would like to arrange a payment plan.

For the duration of the camp, the students will be under the supervision of Evatt School staff. If you have any information that will assist your child to have a successful camping experience please make sure you meet with your child's teacher prior to camp.

As this activity has an outside provider it is not subject to the voluntary contributions policy, and payment is required for the successful running of the camp. Students not attending the camp will follow an alternative program at school, with student numbers determining the activities provided.
